# WHY I HAD TO LEAVE THE CHURCH

AND THE DECISION THAT YOU MUST MAKE

---

## THE BIBLE LED ME IN THIS DIRECTION

---

IN THE BEGINNING when God created the Earth and all that is upon it, He rested. He sanctified that day – the seventh day, and made it holy. It is to be a day of communion between God and mankind. A weekly reminder of the Creator and His creation. He is sovereign and we are sovereign under God, to have dominion over all the Earth. The Sabbath was there at the beginning, before the Ten Commandments were given to Moses, and all knew the Sabbath day. It is to be a sign between God and His people forever<sup>1</sup>, for only they actually keep the commandments of God. Jesus said, “If you love me, keep my commandments”<sup>2</sup>.

Upon discovering and understanding the above profound statements, it perplexed me as to why people worshipped on Sunday. Nevertheless, I searched for a church that kept the Sabbath, which ultimately led me to the Seventh-day Adventist (SDA) Church. I was extremely happy. At last, I had found a holy place that I could call home. Moreover, surprisingly the church began out of prophecy from God. The SDA Church had a modern prophet, which was prophesied for the last day’s remnant church. I knew then, my decision may be solid and well founded. My wife and I were baptized and married at the same time, in the baptismal, dedicating our lives to Yahweh and His Son Yashua whom most people refer to as God the Father, and Jesus Christ our Lord and Saviour.

## THE DISCOVERY

---

Since the early days of America, religious institutions routinely incorporated their denominations and various outreaches. Theoretically, it was a legal means to shield the institutions from liability, catastrophic legal consequences, to perpetuate the work and control in a multi-generational fashion much the same as a business. However, it was the favorable taxation benefits they desired specifically. Few pastors ever stop to consider the spiritual ramifications of their legal structure. It has been deeply ingrained that incorporation is a necessary prerequisite to applying for tax-exempt status. This never seems threatening to the faith of a pastor, conference ‘employees’, or even the congregation at large, for they easily divide their business duties from their scriptural responsibilities.

As American congregations grew and prospered, they formed publishing houses, broadcast networks, schools here and overseas, soup kitchens, and dozens of other outreach ministries. Ever since King Henry VIII broke with the Pope centuries ago, the king was always the designated head of the church. When the colonials came to America, they brought with them a great desire to form their own churches without any state control whatsoever. The American Revolution was related to the desire for freedom to worship God without political constraints. We are not free because the government set us free – we are free because God said we are free, and the government (by way of the Constitution of the United States of America) is supposed to recognize that.

The government, constrained by the Constitution (a contract between ‘We the People’ and elected officials charged with certain public duty), was not only forbidden to tax the church, they were forbidden to regulate it in any way. Under the Constitution of the United States of America, churches are **tax immune**. But in order to neutralize the spiritual and political power the early American churches held, the bureaucracy (ruled by spiritual principalities of wickedness<sup>3</sup>) developed the concept of *tax exemption* – as apposed to *tax immunity*. This system developed a relationship between the church and state. Kind of like – ‘you scratch my back and I’ll scratch yours’, originating surely by Ol’ Scratch. Government granted the incredibly intoxicating *privilege* (as apposed to a right of tax immunity) of tax deductibility for any donation a citizen or corporation gave to churches, assuming that the church had formally received the government’s tax exemption. The churches, in return, **agreed in writing** (i.e. a contract) not to become directly involved in the political process. And every church in America with this tax exemption voluntarily applied to receive it.

So when pastors say they don’t believe the church should be involved in the civil political structure because, they are not called to do that - the truth is, their religious practice is actually in voluntary conformity to what the state has imposed as a condition of receiving their non-profit tax status. For what they are concealing is the fact that they;

- Cannot legally endorse political candidates
- Cannot campaign for specific legislative initiatives
- Cannot directly contribute to political campaigns
- Cannot become involved in the political process

Because they have contractually agreed not to in order to receive the 501c(3) tax exemption from the Internal Revenue Service <sup>4</sup> (IRS).

---

### THE DOWNFALL

---

But surely this cannot be! How could this, or any other church, turn away from their sovereign God? I cannot bear to contemplate the thought, the weight upon my mind, my very soul; it is too much of a burden. I will notify the Conference of this grave error. Surely they do not realize what they have done.

After some research, my conclusion was that they in fact knew of this apostasy – but they turn a deaf ear. Romans Chapter 13 is often quoted, albeit out of context. For it is widely misinterpreted as “we should submit to government”. It in fact teaches the opposite. Paul writes;

*“Know ye not, that to whom ye yield yourselves servants to obey, his servants ye are to whom ye obey; whether of sin unto death, or of obedience unto righteousness?”<sup>5</sup>.*

Legal dictionaries define a corporation as an “artificial person”. The word comes from the Latin word “corpus”, meaning a body. Is it a Freudian slip we get our word “corpse” from the same word as corporation? This artificial person is actually a creation of the government that incorporated it. In short, the government is the creator and “head” of all corporations. What is wrong with that you ask?

*A corporation is not deemed a person within the clause of the Constitution of the United States protecting the privileges and immunities of citizens of the United States from being abridged or impaired by the law of a State, and the liberty guaranteed by the Fourteenth Amendment against deprivation without due process of law is that of natural, not artificial, persons.<sup>6</sup>*

In other words, even though the corporation is viewed as an artificial person, it does not enjoy any of the God given rights of a natural person. “The government no longer recognizes its legal status as a ‘church’, separate and protected from the government by the Constitution, but as a ‘creature’ and a ‘creation’ of that government”.<sup>7</sup>

*Upon the other hand, the corporation is a creature of the State. It is presumed to be incorporated for the benefit of the public. It receives certain special privileges and franchises, and holds them subject to the laws of the State and the limitations of its charter. Its powers are limited by law. It can make no contract not authorized by its charter. Its rights to act as a corporation are only preserved to it so long as it obeys the laws of its creation.<sup>8</sup>*

According to the Bible, Jesus Christ instructs Christians “... to be conformed to the image of his Son”<sup>9</sup>, not transformed into an “artificial being created by law”<sup>10</sup>. “For a man indeed ... is the image and glory of God...”<sup>11</sup>. **He is not to be transformed into the image of the artificial beings creator.** The majority of churches today are closely aligned with the beast governments of the world through their fundamental structure. This issue supercedes doctrine. Indeed, it is the single common denominator between every religious institution in the entire world with its myriad interlocking directorates, i.e. a series of interconnected corporations – ie. all under the beast system.

## THE DILEMMA

---

Do you see the dilemma yet? The bible teaches that Jesus Christ is the head of the church<sup>12</sup>. You cannot serve God and man.<sup>13</sup> You see, an incorporated church is in every sense under the control and direction of its creator – the government. By every sense, I mean legally, ethically, morally, financially, and even spiritually. This has profound spiritual consequences as mentioned herein, and because God places a great deal of emphasis on the law (the ten commandments) and judges mankind based on conformity or rebellion relative to the law of God. (see I John 3:4) One of which is – “Thou shalt have no other gods before me”<sup>14</sup>.

*The registered agent is not the representative of the corporation to the State. He is the representative of the State to the corporation, and he is accountable to the State...".<sup>15</sup>*

In other words, the pastor of your church, or anyone who is holding this office, has a legally binding responsibility, and allegiance to the State. He is therefore a government agent, which must comply with the dictates of, and be loyal to, the head of that church – the (beast) government. This is why they tell me, that I must comply with the beast government system. I am not that naive. Are you?

So, what are our choices? What is the solution?

1. We could endeavor to change our churches from the top down. However, with the infiltration of Jesuit Priests from Rome within our churches and Christian schools – I believe this to be an impossible alternative.
2. We could unite and form another church. However, being this close to the end, I fear there is not enough time.
3. We could join other churches that are not incorporated. But only if they have the truth and keep the commandments of God.
4. We could teach in our homes and gather for Sabbath worship. This may be the only alternative in a world full of government ‘spies for money’, corruption and delusion.

Isn't this what Ellen White suggested?

## THE DECISION

---

“COME OUT OF HER MY PEOPLE, that ye be not partakers of her sins, and that ye receive not of her plagues”.<sup>16</sup> Is this the Catholic Church? The Baptist Church? Any protestant church? I believe the angel was referring to any apostate church. If you only knew how it pains me so referring to the SDA Church in that manner. Nevertheless, I am Yahweh's servant. Christ is my Lord and Saviour and I bow to no one else. I remain loyal to Him only and will never forsake Him. Surely dear friend, you feel the same way.

I cannot in good faith be a part of, especially a member of, a so-called church who has relinquished Christ as the head of the church for a government granted privilege of serfdom. That church has in fact sold its birthright for money. I refuse to cooperate with those that “frameth mischief by a law”<sup>17</sup>, or with the “prince of the power of the air”<sup>18</sup>.

What about forsaking the assembly of ourselves together? I will not ignore 20 other verses instructing me to have “no fellowship with the unfruitful works of darkness”<sup>19</sup>. I ask you – how can the church refuse to heed the instruction “bear ye one another’s burdens”<sup>20</sup> and to “do justice to the afflicted and needy”<sup>21</sup>, instead passing this responsibility off to some three letter named government agency. Or that by incorporating and seeking legal remedy and protection from lawsuits, you refuse Paul’s teaching to the Corinthians that “... there is utterly a fault among you that ye go to law one with another”<sup>22</sup>. He further stated that Christians are not to “goeth to law with brother and that before the unbeliever”<sup>23</sup>. I beseech you brothers and sisters that the sin was submitting to the authority of the unbelievers, for you will have thus become “conformed to this world”<sup>24</sup>.

**I must therefore, rescind and revoke my membership within the Seventh-day Adventist Church, and will not be a part of any 501-c3 incorporated church.** When the beast kingdom is finally destroyed at the return of Christ our Lord, we dare not be found in submission to the beast or its system. What about you my friend? Will you rationalize your conformity to the beast system by twisting the scripture because you are afraid of the consequences of this world?

*... for what fellowship hath righteousness with unrighteousness? And what communion hath light with darkness? And what concord hath Christ with Belial? Or what part hath he that believeth with an infidel? And what agreement hath the temple of God with idols?*<sup>25</sup>

Unincorporated Christian churches have been seized in Oregon, Texas, Indiana, and indeed all around the world. Pastors and elders have been jailed and fined for refusing incorporation and state licensing. Their buildings stolen and auctioned off by the very government who swore to uphold our God given right to worship. Rogue federal authorities are now actively going after patriots and Christians who oppose big brother’s police state. We have seen the murder of Danny Casalaro and the shooting of short-wave radio personality William Cooper. Jim Keith, author of *Black Helicopters over America*, and other books suffered a strange death. His publisher, Ron Bonds of Illuminati Press, also recently died after ingesting a mysterious poison. Are you aware of what is going on?

Your church pastor is forbidden to mention these to you. One well-known researcher was recently indicted for hoaxed-up crimes he did not commit after authoring a book exposing jewish supremacism.
